This charter sets out the terms of use of the Azzurra platform of the Université Côte d'Azur computing center:

- This charter applies in addition to the « [Charte de Bon Usage de l'Informatique et des Réseaux](#) » of the University of Nice Sophia-Antipolis (provided in the appendix).
- For external users (Université Côte d'Azur industrial and institutional partners), this charter applies in addition to the Special Conditions of Use of the platform between the partner and Université Côte d'Azur.
- For users with rights to OPAL, it applies in addition to the OPAL charter (to be finalized) and the agreement between the OPAL partners (to be finalized).

Data processing and GDPR (*General Data Protection Regulation*) compliance of the platform

Each user is responsible for her/his data processing on the platform. She/he is thus responsible for ensuring adequacy (trustfulness) between the equipment used and the level of sensitivity of his data, in particular in terms of GDPR and level of classification of the data.

To allow the proper functioning of the platform and carry out usage reports, the platform records personal data:

- nominative data communicated by the user when opening or extending the account;
- characteristics of jobs launched by the user (user ID) on *Azzurra*

The data concerning the user's the identity, civil status, contact details, professional life or education are kept 10 years before anonymization or destruction. Connection data are kept for 1 year before anonymization or destruction. The data is accessible to the platform's technical team and scientific committee. The characteristics of the works are also accessible to other users of the platform.

The usage statistics (published more widely) are aggregated and anonymous.

The computing center machines are physically hosted at INRIA Sophia Antipolis Méditerranée - 2004, route des Lucioles - BP 93 - 06902 Sophia Antipolis Cedex. The hosting agreement between INRIA and UCA (draft version) can be found in the appendix.

And I commit to:

- Abiding by the terms set out in the above mentioned charter, and in particular the following ones:
 - The account opened on *Azzurra* is strictly personal, you must in no case give your password or lend your account to a third person, even temporarily.
 - The account on *Azzurra* is independent from the computer account of Université Côte d'Azur.
 - You agree to use the software resources installed on *Azzurra* by the technical team, and use no other resources.
 - You are responsible for your account and its use. As such, you must report any fraudulent use of your account.
- Using the Centre IT resources exclusively for carrying out the work described in this document and within the framework of a scientific project approved by the Scientific Committee.
- If your project involves the processing of personal data, this must be documented beforehand in accordance with the DPO of your structure. You commit to communicating on request the corresponding compliance documentation.
- Anonymizing or pseudonymizing any sensitive data used on *Azzurra*.

- Performing your own data backups. Université Côte d'Azur computing center ensures data security via RAID storage but does not provide any data backup or archive. If the user is not a permanent member of Université Côte d'Azur, her/his data will be deleted at the end of her/his contract.
